The Satellite is primarily comprised of opportunistic investment strategies. Cardinal Point employs high-yield bonds, select global equity mandates, various alternative investments, as well as sector concentration positions for this strategy. The function of the Satellite is to increase diversification by introducing assets that have low correlation to the Core component.

#### Personal balance sheet and income statement creation

The balance sheet is a tool that provides a financial snapshot of our entertainment and media professional's financial health. It compiles assets, liabilities and computes net worth. Additionally, the income statement is an equally important document that provides insight into cash flow management. Both documents are staples of the planning process.
